Dear Group Leader:

Thank you for scheduling a day of paintball at The Land Paintball Field. We want to take this opportunity to remind you about some important items that will make your check-in process quicker and your visit a pleasure.

1. To reserve the field on a Monday-Friday you must have a group of 25 renters or more or you must have a group of 35 non-renters and renters mixed. **(See #2 for no minimum requirement days Saturdays and Sundays.)**
2. If you bring out your group on a weekend Saturday or Sunday then there is no required amount of people you must bring. **A deposit of 100.00 is still required.**
 - Any group that comes on a weekend will not be able to rent out the field to themselves but will have the option to play among themselves. OR
 - For additional fee your group may have a private party with private field and referee.
3. **For groups of 15 or more, if your actual group number falls short of the scheduled number of guests, you will be charged for all of the scheduled number of guests. If you have a need to change the number in your scheduled group, it must be done at least two (2) days prior to your arrival to avoid full charge.**
4. At the time you were asked to submit a deposit of 100.00 or more for your group. If you have done so, thank you. If you have not, we cannot hold your groups spot until this is done. Deposits must be received immediately upon scheduling. **Cancellation of reservation requires a seven (7) day notice prior to your scheduled date for return of deposit.** After then your deposit will be applied for a later date and will not be refundable. Deposits can be done over the phone.
5. **Please collect all money from your group prior to arriving at the clubhouse entrance so that your time at the field can be maximized.** Any intentional destruction of property could result in a charge 4 times the cost.
6. All participants must have a waiver filled out. All participants that are under the age of 18 must have their parents sign the waiver as well. Waivers can be obtained at www.landpaintball.com. I have also included a copy of the waiver that can be copied and filled out prior to coming. All participants must be 10yrs of age.

In consideration of being permitted to participate in any way in the sport and activities of paintball, under the rules and regulation of **THE LAND PAINTBALL**, I acknowledge, appreciate and agree that:

2. **I KNOWING AND FREELY ASSUME ALL SUCH RISKS**, both known and unknown, **EVEN IF ARISING FROM THE NEGLIGENCE** of those persons released from liability below, and I assume full responsibility for my participation, and;
3. I understand that the activity of paintball is physically and mentally intense. I understand the rules of play and will comply with all rules and regulations. If I observe any unusual or necessary hazard during my participation, I will bring such to the attention of the management as soon as practical, and;
4. I, for myself and on the behalf of my heirs, assigns, personal representatives and next of kin, **HEREBY RELEASE AND HOLD HARMLESS THE LAND PAINTBALL, THE OWNERS AND LESSORS OF THE PREMISES** used to conduct the paintball activities, their **OFFICERS, OFFICALS, AGENTS, VOLUNTEERS**, and/or **EMPLOYEES (know as "RELEASEES") WITH RESPECT TO ANY INJURY, DISABILITY, DEATH**, or loss or damage to person or property, **WEATHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE.**

I HAVE READ THIS RELEASE OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT, FULLY UNDERSTAND IT'S TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT AND SIGN IT FREELY AND VOLUNTARILY WITHOUT INDUCEMENT.
